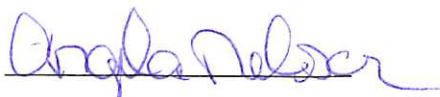
- j. Discussion and/or Action: Volunteer Form/Waiver of Liability for volunteers for City of Point, Texas.

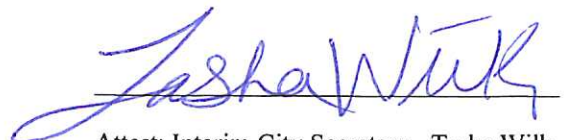
ADJOURNMENT
